# HIGH SCHOOL BOUNDARIES

# **July 2012**

*Unless otherwise specified, all boundary lines refer to an imaginary line down the middle of the street.* 

# Centennial (9-12)

Beginning at a point where the Arkansas River would intersect with the western boundary of School District 60; the western and northern boundaries of District 60 are the boundaries for Centennial High School; eastern boundary for Centennial: south at the point where Fountain Creek intersects with the northern boundary of the district to a point where E. 17th Street would intersect; east on that plane to Kingston; south on Kingston to E. 2nd Street; west on E. 2nd Street to Iola; south on Iola to the Arkansas River; west on the Arkansas River to a point where the Arkansas River would intersect with the western boundary of District 60.

## **Central (9-12)**

Southern boundary of Central High School: Beginning at a point where Beulah Avenue intersects with the District 60 southern boundary; north on both sides of Beulah Avenue to Northern Avenue; west on both sides of Northern Avenue to Prairie; north on both sides of Prairie to Amherst; west on both sides of Amherst to St. Clair; west on north side of St. Clair; west on north side of St. Clair to western boundary of District 60.

Northern boundary of Central High school: Beginning at a point where the Arkansas River would intersect with the District 60 western boundary; east on the Arkansas River to a point where Aspen Street would intersect; the eastern and southern boundaries of School District 60 are the boundaries of Central High School to the point where Beulah Avenue intersects with the District No. southern boundary.

### East (9-12)

Beginning at a point where Iola Avenue would intersect with the Arkansas River; north on the plane of Iola Avenue to E. 2nd Street; east on E. 2nd Street to Kingston Avenue; north on Kingston Avenue to a point parallel to where E. 17th Street would intersect; west on that plane to Fountain Creek; north on the Fountain Creek to the northern boundary of District 60 (between 1800-1900 Overton Road); the northern and eastern boundaries of District 60 from Fountain Creek are the boundaries of East High School; beginning at a point where the eastern boundary of District 60 intersects with a AT&SF Railroad tracks; west on those tracks to a point where Townsend Drive would intersect; south on Townsend Drive to the Arkansas River; west on the Arkansas River to a point where Iola Avenue would intersect.

# **South (9-12)**

Southern boundary of South High School: Beginning at a point where St. Clair Avenue would intersect with the western Boundary of District 60; the western and southern boundaries of District 60 are the boundaries of South High School where the southern boundary intersects with Beulah Avenue.

Northern Boundary of South High School: Beginning at a point where Beulah Avenue intersects with the District 60 southern boundary.

To Central: North on both sides of Beulah Avenue to Northern Avenue; west on both sides of Northern Avenue to Prairie; north on both sides of Prairie to Amherst; west on both sides of Amherst to St. Clair Avenue; west on south side of St. Clair to western boundary of District 60.
