

Instructions for use of Written Description of Curricula Form:

The Written Description of Curricula document is to be used by parents opting to homeschool their child(ren) who have been habitually truant in the six months prior to applying. Habitually truant is defined as having four unexcused absences in one month or ten unexcused absences in one calendar year.

A Notice of Intent to Homeschool form and the Written Description of the Curricula form must be completed and filed with the Pueblo School District 60 Homeschool Coordinator before a child can be officially withdrawn from the school. The current school year's Notice of Intent to Homeschool form can be found on the Pueblo School District 60 Home Education website.

State statute requires that parents provide their school district with a written description of curricula to be taught prior to the establishment of a home-based program.

CRS 22-33-104.5 (3)(b) A child who is participating in a nonpublic home-based educational program shall not be subject to compulsory school attendance as provided in this article; except that any child who is habitually truant, as defined in section 22-33-107 (3), at any time during the last six months that a child attended school before proposed enrollment into a nonpublic home-based educational program may not be enrolled in the program unless the child's parents first submit a written description of the curricula to be used in the program along with the written notification of the establishment of the program required in paragraph (e) of this subsection (3) to any school district within the state.

The Written Description of Curricula document covers subject areas required by the state statute. You must provide a plan (hours per day, and concepts to be taught), as well as the title, author, publisher, and table of contents page for each book you plan to use to teach the required subjects before the Homeschool Coordinator can approve your curriculum.

In the event that you will not be using a formal set of curricula (textbooks) but rather a mixture of materials for one particular subject area, all materials to be used should be listed along with the table of contents for each book (Photocopies are accepted). If using online curricula, provide a list of the subjects and the hours per week to be spent online, along with the curriculum provider contact information.

Parents are responsible for selecting the curriculum to be used when homeschooling. **Pueblo School District 60 does not provide curricula or instructional materials for homeschooling students**.
